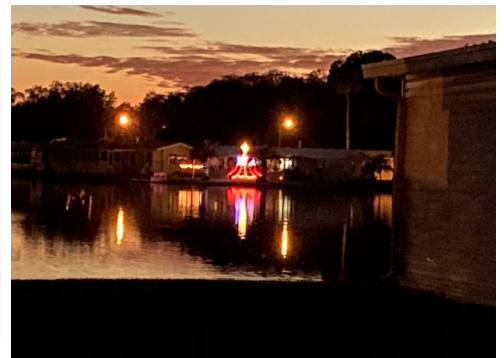

Message from the Desk of Carolyn Keithley

Forest Lake Estates Homeowners' Association (FLE HOA) President

I hope everyone is as glad as I am to see 2020 go! What a year this has been. It's hard to believe that since March 13th we have not been able to gather and carry on with our activities as we have in other years. The HOA Board is trying very hard to keep everyone in our community as safe as possible. We do not want to place anyone in jeopardy because of an event that we have sponsored or held. Your health and safety are a primary concern of the Board. We are aware that we have had a few cases of Corona Virus in our park and are truly thankful that everyone has recovered.



We continue to meet regularly with ELS. We have not been able to accomplish a lot with them, but we keep pushing and asking for things that we feel are in the best interest of our community. I hope everyone noticed that the maintenance shed is up and the fencing has been placed. The small storage shed next to the trash area belongs to the HOA. It was provided by ELS.

The repairs to the post office building will most likely not begin until sometime in January. We will keep you updated as we get closer to the repair.

We do need your help with something. When residents file a concern with the office, we are not made aware of the concern unless you, the resident, provides us with a copy of the form. We meet monthly with ELS and if we have no paper trail, we have no recourse to follow up on concerns. If you file a concern form with the office, we are asking that you have an ELS employee sign and date the form and make you a copy. If you would then bring us a copy of that signed and dated form or even just drop a copy in the box by the clubhouse door, we then can follow up during our meetings. Without these copies, we have no paper trail and it makes it difficult to get the issues resolved. Thanks for your assistance with this.

We have had a few issues brought to our attention. Parking on the street overnight is a major one. Please review your rules and regulations. Parking on the street overnight is not permitted. If you are unable to park your vehicle in your driveway, then it must be parked in one of the visitor's parking areas. If the area someone is parked in is not lit adequately, accidents are possible. So let's think of our neighbors and keep those vehicles off the street at night.

I want to thank everyone who assisted with putting up the Christmas tree, nativity scene and deer in Memorial Park. They all look beautiful. In fact, Harold and I make regular trips around the park just to look at the lovely Christmas decorations! They are absolutely beautiful this year. 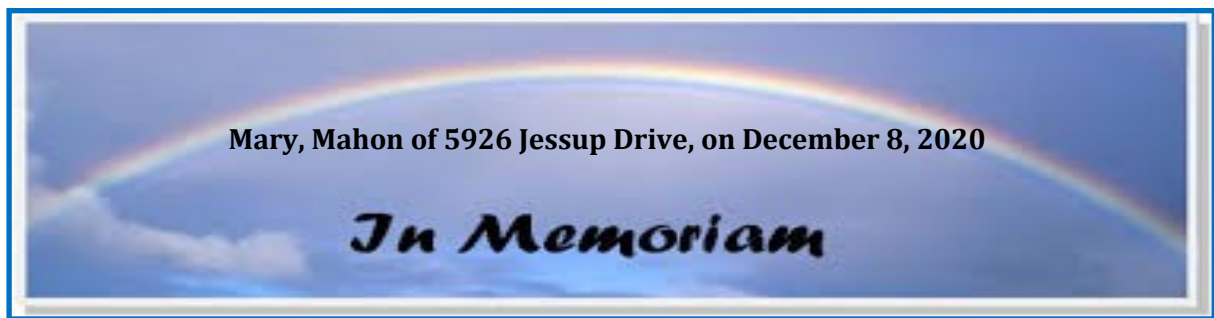
Hopefully, with the start of the new year, we might be able to see more of our snowbirds returning. Just remember to stay safe and join us when you can.

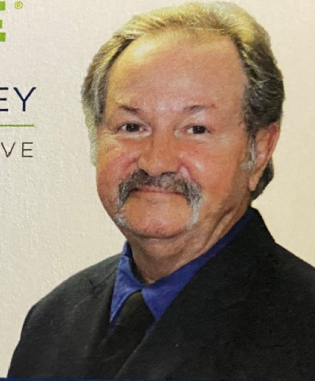

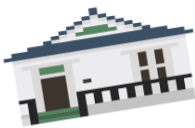
Lending for Little Ones

Capital Expenditure Projects

We use this phrase Capital Expenditure Projects a lot, but does everyone really understand what it means?

We are asked each year to submit items for CapEx projects. These are changes/additions that the residents would like to see made in the park, that have an associated cost that exceeds regular maintenance budgets. ELS sets an annual budget for these projects. In May of each year, the HOA submits ideas to be considered as CapEx projects for the following year. You may recall that during our General Meetings in March and April, we asked that if you have ideas for these projects that you provide the information to a board member.

Our most recent CapEx Project was the addition of the walk in cooler/freezer in the kitchen. The request for this addition had been submitted a few times, but it was the only item submitted for year 2020. The request was approved and the project was completed for 2020.

Last winter we had issues with the temperature of the water in our pools. HOA Vice President Mike Black formed a committee to research options. The committee spent a lot of their own time meeting with vendors to research possible solutions and in May 2020, the HOA submitted a CapEx Project request, which outlined three possible solutions to upgrade the pool heating system. We are waiting to hear if that project has been approved and will provide you with that information as soon as we are provided with their decision. If it is approved, the work will be performed sometime during 2021.

Since we are in an emergency pattern and meetings are not being held, if you have ideas for CapEx projects for year 2022, please submit your idea to any board member. If you have questions about CapEx projects, please let us know and we will try to help you better understand the process.

...Some News about Activities and Events

From the desk of Mike Reid, Activities Director

I hope everyone had a wonderful holiday season. As we start the new year, the HOA board has decided to publish the calendar (see page 24) for recurring activities so residents can begin gathering in a safe manner and enjoy their daily activities. The protocol set forth by ELS for participating in events in the clubhouse are still in place.

The board has also decided that all major activities/events, like Bingo, Sandwich Night, Ice Cream Social, etc., will still be on hold until at least February. As a board, we will reevaluate in mid-January to determine how we will proceed. Now with the distribution of the vaccine, we hope to see changes in the numbers, which should allow us to get back to some form of normalcy. We thank you for your patience while we continue to navigate this ever changing environment. Our goal is to maintain the safety of our residents while still being able to provide some form of activity.

I have been working on trying to get some more food trucks in the park. Keep an eye on your email for updates on this. Happy New Year !!!! Here is hoping it is better than the last!

ASK the HOA

QUESTION: If a resident moves out of the park, how are they getting back in to use our amenities?

ANSWER: We discussed this issue with ELS at our last meeting on December 9, 2020. Generally, when a resident moves out of the park and no longer owns a home here, the bar code and their blue key fob are disabled to prevent them from coming into the park as a resident would. ELS advised that they had fallen behind in the task of disabling those items, but would make it a priority.

COMMENT: Once the bar code and key fob are disabled, you could still see former residents in the park, however, someone here would have had to let them in through the visitors gate. If the former resident is truly coming to visit you, that is not a problem. However, if you are allowing the former resident to enter the park for the sole purpose of using our amenities, we would kindly ask that you discontinue this practice. If the former resident doesn't pay rent here, they should not be coming in to use our amenities at the expense of our residents.

QUESTION: I walk the park two or three times a day and have been noticing a lot more cigarette butts on the ground. Could you please address this?

ANSWER: As the editor, I must say that while walking my dog, I have noticed this also. Residents, please dispose of your cigarette butts in an appropriate way. It can take 18 months to 10 years, yes I said 10 years, for a cigarette butt to decompose, and no one wants to have to look at that for 10 years. Please consider carrying some type of container in your golf cart or vehicle to avoid throwing them on the ground.

The purpose of the Forest Lake Estates Home Owners' Association (FLE HOA) is to ensure our membership and our perspective members are aware of the goals of our Association. We are now conducting our 2021 Membership Campaign.

Our mandate is to:

- Operate an Association encompassing the well-being of the business affairs of the Forest Lake Estates Home Owners' Association.
- Promote FRIENDSHIP and HARMONY between FLE HOA and the Park Owners, ELS .
- Ensure rent increases are REASONABLE AND WORTHY; and,
- Ensure ELS is in compliance with 723 F.S., the Prospectus, and all exhibits thereto.

While it is important to maintain a harmonious relationship between FLE Residents and ELS, it is also important to know that the FLE HOA stands firm on these mandates. All Forest Lake Estates residents have an investment that must be protected. The FLE HOA is the ONLY entity recognized by the State of Florida to represent all of the residents in the Park. The HOA works with ELS to assure that the park is maintained appropriately and to protect the best interests of all residents. All residents are encouraged to join the HOA and support the HOA Board of Directors as they work to support you. From November through Mid-January, membership sales are held in the clubhouse on Mondays from 10:00AM until 12 Noon. The dues are \$20 per household per year and are deposited into our general fund to be used for operating expenses, activities and legal support. Members who provide an email address will receive the monthly newsletter, minutes of membership meetings and any announcements via email. You may choose to have a hardcopy newsletter delivered to your home November to April. Newsletters are only delivered in the summer to members without email. Board Members are elected each year in January. You must be a paid member to be eligible to run for a seat on the board and to vote in the election.

ASSOCIATE MEMBERSHIPS are available for Renters only

Message from the Management Office



Pool Water

Too warm, too cold, or just right?


Much like the saying, "beauty is in the eye of the beholder," the ideal pool temperature is determined by the comfort of the swimmer. We're pleased that the community swimming pool is one of the most popular amenities at the property, and we want to keep it that way. We realize there will always be differences of opinion regarding the perfect temperature of the pool. Casual swimmers and early morning swimmers often prefer warmer water, while afternoon swimmers and those participating in activities like water aerobics or lap swimming often prefer cooler temperatures.

We aim to find a middle ground for the temperature of our pool in order to make it reasonably comfortable for as many swimmers as possible. For this reason, heaters are utilized to maintain a temperature from 78-82 degrees. The water may become warmer than this, however, as it is heated by the sun. Similarly, if the weather is unseasonably cold, it may be difficult to reach the desired temperature. While we realize this may not result in the perfect temperature for each individual swimmer and that person's activity level, our hope is that it achieves the balance we strive for in order to accommodate the preferences of as many of our residents as possible.
